



## Ohkay Owingeh Tribal Council Resolution #2023-18

### 2023 Tribal Distribution

WHEREAS, The Ohkay Owingeh Tribal Council and its Tribal Members will soon celebrate its Annual Feast Day in honor of the Pueblo's Patron Saint, St. John Bautista on June 24, 2023 and

WHEREAS, The Ohkay Owingeh Tribal Council respects and encourages the participation of Tribal Members in all community activities (i.e. traditional dances, ditch work and community meetings and clean-ups), and

WHEREAS, The Ohkay Owingeh Tribal Council wishes to share with its people and to assist with the celebration of Ohkay Owingeh Feast Day, and

NOW THEREFORE BE IT RESOLVED, that the Ohkay Owingeh Tribal Council does hereby declare that enrolled Tribal Member's in good standing, will be eligible to receive **\$200.00** which will be distributed on Thursday June 15, 2023 from 8:30 a.m. – 5:00 p.m. at the Ohkay Owingeh Tribal Council Chambers, and

- A. The head of each family or household (Father, Mother, etc.) should pick up the distribution for the members of the family **under** 18 years of age. Information on children's "official" custody must be made available during distribution or arrangements made in advance of distribution day.
- B. **Tribal Members must pick up, in person, their own distribution. No exceptions will be made.**

Note: A picture ID i.e., state issued driver's license, state issued identification card, etc. will be required for Tribal Members residing *outside* of the Ohkay Owingeh Land Grant.

- C. Tribal Members must submit the distribution form prior to distribution day however distribution forms will be available to submit on the actual distribution day. Distribution forms will be

available at the Ohkay Owingeh Tribal Administration building front desk at [www.ohkay.org](http://www.ohkay.org).  
The deadline to submit distribution forms is COB on 6/9/2023.

- D. Tribal Member's over 18 years of age should pick up their own distribution **in person** whether head of household or not. Head of household is considered to be enrolled tribal members over the age of 18 regardless of living situation.
- E. Only those individuals who are on the official Ohkay Owingeh Tribal Census Roll dated June 1, 2023 shall be eligible for this distribution.
- F. 2023 Tribal Fund distribution will be limited to June 15, 2023 from 8:30 a.m. to 5:00 p.m. No exceptions will be made, and

**BE IT FURTHER RESOLVED, THAT THE Ohkay Owingeh Tribal Council may declare distribution to enrolled tribal members each year provided that tribal funds are available and that in subsequent year's distribution may not be declared due to Tribal Distribution funds that will be obligated to Capital Projects and Program Services that address the critical needs of the community.**

CERTIFICATION
