Continuous efforts are being made to develop programs and other resources that address immediate concerns (ie. remote learning, telehealth and telework) but also build the capacity of Tribes to use broadband to provide ongoing and sustainable benefits to Native American communities. TruNet Internet Services, LLC, in collaboration with Ohkay Owingeh Administration, greatly appreciate and encourage your participation with the attached survey/application for a Tribal Broadband Connectivity Program. We have completed the installation of the wireless broadband infrastructure, and plan to tentatively deployment of the program on September 1, 2023,

To be considered eligible for the Tribal Broadband Connectivity Program each tribal household located on tribal lands in Ohkay Owingeh must complete this survey/application. Surveys/Applications must be received by returning them to the Governor's Office, or by email to [broadband@ohkay.org](mailto:broadband@ohkay.org). Incomplete Applications will **NOT** be processed. This program will also provide monthly internet service for an extended period of time of 2 years, at which time tribal members will be responsible to continue payment for internet service. We will provide a 25MB upload, 7 MB download connection but other packages will be available to tribal members at less expensive cost.
